## Who is Eligible?

Minority students enrolled in K-8 and regularly attending a Catholic parochial school in the United States.

# **Family Interview**

A personal family interview/meeting will be conducted at the time the application is selected as eligible for an award. The interview may be conducted via videoconference if distance makes a physical meeting impractical.

## **Amount of Award?**

The amount of each award may vary and is based upon need, tuition and available funds.

#### **How is it Paid?**

The monetary award is paid in two installments. The first is paid at the beginning of the school year and the second in the middle of the school year.

#### Who is Paid?

The monetary award is paid directly to the student's school for credit to his/her tuition account.

## **Please include:**

- 1. Verification that student attends the chosen school.
- 2. Detailed copies of all pages and schedules of Federal Income Tax Form 1040, 1040A or 1040EZ (as filed with the IRS) for individuals responsible for tuition.

<u>Application Deadlines:</u> Applications will be reviewed twice a year. The deadlines for filing your application are June 30<sup>th</sup> and December 31<sup>st</sup>. Decisions are rendered within 30 days after the application deadlines and you will be notified accordingly if selected for an award.
